## BEACH OPERATING HOURS

November to March - From 09:00 to 17:00  
April and October - From 09:00 to 19:00 / admission allowed until 18:00  
May to September - From 08:00 to 21:00 / admission allowed until 20:00

Admission to the dining areas is free after 19:30 pm by reservation only and subject to availability.

Entry to the facilities of the Beach ("ASTIR BEACH ") is permitted to those upon purchase of the relevant ticket.  
The cost of the ticket as well as the privileged packages are defined by the company " ASTIR BEACH SINGLE MEMBER S.A."

## PRICE LIST

For the convenience of visitors, the Company has created privileged membership packages and loyalty reward programs to meet their needs and requirements.

For information, guests can contact the Beach Management. The entrance to and exit from the Beach are permitted only from the allocated points, as outlined by the Company, through the Beach Management. All persons require a ticket for the use of the Beach, with or without an umbrella or seat. This ticket does not include a tour, guided tour or visit to the Temple according to the terms set by the Ministry of Culture.

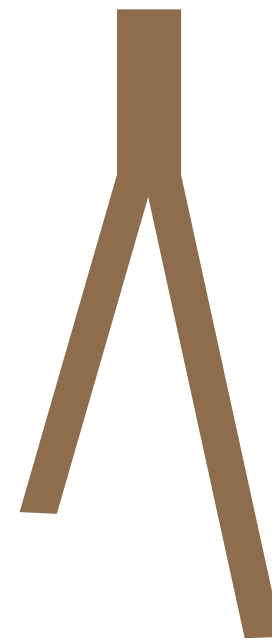

## SHOPS

At the Beach, there are shops and restaurants which operate as independent companies at the disposal and complete service of the ticket holders. It is explicitly forbidden to visit shops and restaurants without the purchase of an entrance ticket.

## FIRST AID

Opening Hours Summer Season: 10:00 – 18:00

The Beach offers First Aid to visitors in the event of emergency medical requirement, as defined by law. All guests are kindly requested to provide the necessary information to the Doctor or Nurse who will attend to them.

Guests must follow the guidelines provided to them.

In the event of serious injury, guests can leave the medical centre on signing of all necessary documents and at their own risk. When the injured person is a minor, he / she is only able to leave the First Aid centre if accompanied by a parent or guardian.

The First Aid unit is equipped with the appropriate medicines and equipment to attend to serious incidents. The use of medicines will only be prescribed after the advice of the Doctor, who has full responsibility for the patient's / injured person's care.

For the most effective operation, it is recommended that visitors to the Beach inform the Beach supervisor, should they suffer from a chronic health problem or a serious medical history before using the Beach facilities and, especially, before engaging in water sports.

## LIFEGUARD

The Beach provides the legal number of lifeguards and hours of their presence by the relevant provisions for the operation of the bathing facility. This is listed in a prominent place for the information of bathers.

Visitors should follow the instructions, suggestions, advice, and remarks of the lifeguard on duty.

In the event of extreme weather conditions or sea pollution, the Lifeguard can prohibit swimming on obtaining prior approval from the Beach Management and Port Authority.

When the Red Flag is raised at the Lifeguard Tower, visitors should be aware that there is no Lifeguard on duty and swim at their own risk.

The Beach has been specifically demarcated with precise markings not under the supervision of a Lifeguard and visitors should understand that swimming outside these limits is at their own risk.

Visitors who suffer a health problem should notify the Lifeguard prior to any activity at the Beach.

## SECURITY OF AREA

The Company and Beach Management are not responsible for any inappropriate behaviour of guests as well as problems or accidents that may arise from such behaviour.

Children should be under the constant supervision of their parents or guardians, who should be aware of the potential dangers that may occur at a busy beach. Guests are kindly requested to maintain their entrance ticket during their stay at the Beach and upon request, present it to the Beach Supervisors for inspection. Given that the site has CCTV surveillance, interested parties may contact us to exercise their rights under applicable privacy laws, including national laws and regulations, the European Union General Data Protection Regulation (EU 2016/679) and instructions, which are published by the competent supervisory authority, are recognized as the subject. The Beach meets all modern fire safety standards and has all the obligatory legal permits required for the operation of the organized Beach. The tenants of the shops and restaurants that operate within the Beach must have these specifications and permits at all times.

The Beach employs a person responsible for the maintenance of its facilities, who manages and supervises the timely execution of its maintenance and repair works.

## SAFETY DEPOSIT BOXES

At the Beach entrance, guests can obtain a key at a small charge, enabling them to secure their personal items in special cabinets located in the locker rooms. The Company will not be liable for any loss of valuables. If the safe locker section is out of operation, the guests will be accountable for the safekeeping of their own personal belongings. For lost items or items that visitors want to hand-in, they should contact the lost & found department which manages lost items ((+30) 210 89 01 619).

## LOCKER ROOMS, SHOWERS

Shower facilities are available along the Beach. There are two categories of showers:

a. Exterior Showers, which are located at three points on the Beach. The use of shampoo / soap and related items is prohibited here.

b. Indoor Showers, located next to the locker room. Here, the use of shampoo / soap and related items is allowed.

## NOT PERMITTED:

1. Admission of pets
2. Use of personal umbrella, sunbed, or chair
3. Camping
4. Picnic/ delivery
5. Ball and racket games, except within the specifically designated areas (prohibited on the shore due to client safety)
6. Temporary exit from the Beach, other than in exceptional circumstances and always with the permission of the Beach Management
7. Swimming outside the floating buoys zone
8. Entrance and exit from other places, except via main Beach entrance - exit
9. Entry to any area, without a ticket purchase or prior permission from the Beach Management
10. Circulation in areas of the Beach, where bathers are prohibited, according to the existing signs
11. Use of a private sound system at a volume which disrupts other bathers
12. Use of free-to-use seats other than for the use provided (occupation of free-to-use seats for storing clothes, bags, etc.)
13. Use of shampoo or other chemical liquids in the outdoor showers of the Beach
14. Destruction of any kind and for any purpose of vegetation outside the boundaries of the Beach. Destruction of the environment is a criminal offense.
15. Pollution of sea water
16. Destruction or other deliberate damage to equipment, machinery, or facilities of the Beach Offenders will be prosecuted for damaging foreign property
17. Use of locker rooms for purposes other than those legally set
18. Remaining at the First Aid Station for people other than the Nursing staff, patients, and their attendants
19. Remaining at the Lifeguard Tower, without the relevant special permission of Beach Management
20. Use of vessels
21. Use of wheeled vehicles on areas of the Beach, except in cases where a special permit has been granted by the Beach Management
22. Use of bicycles and skateboards on areas of the Beach
23. Bathers remaining on the Beach beyond opening hours
24. Exclusive use of cabins
25. Reservation of umbrellas
26. Parking of cars and motorcycles at the area in front of the main Beach entrance
27. Nudism
28. Use of drones
29. Any type of fishing
30. The anchoring / mooring of any watercraft, boat, vehicle on the platform of the ski club throughout the day, except for any water means of transportation or water toy belonging to the ski club. Exceptions for emergency needs will only be granted upon written request and pending approval from the company's Administration and upon notification of the Coast Guard.

The use by anybody of recording video or audio in public areas automatically supposes the conformance of the Law and especially the relevant legislation relating to the protection of personal data and copyright. The use of such recording devices is the sole responsibility of the bathers, visitors or tenants, and the Company does not bear any responsibility towards anyone for any violation of the Law.

Visitors, bathers and tenants of the stores and restaurants are obliged to respect the area where the Temple of Apollo Zostiras is located, near the Beach entrance, as well as being expressly prohibited from violating or trespassing on the site of the above Temple.

Any special conditions for the Temple established by the Ministry of Culture must be applied in accordance with this Regulation by visitors, bathers, and tenants on the Beach.

## PERSONAL DATA

The Company legally and responsibly uses information collected from you when using the services of the Beach and takes every reasonable measure to protect your personal data.

When you use the Beach, the Company processes the following categories of personal data, as appropriate:

- Identification information (name, surname).
- Contact details (indicative: address, phone, email).
- Image data collected through closed circuit television from the entrances and exits of the area as well as in places where the installation of cameras is deemed necessary for the protection of persons and goods, and fully complies with the legal framework for the protection of personal data.
- Health information only when necessary for the provision of first aid.
- Vehicle license plate only for PLATINUM program members and Platinum Card holders.
- Any other information that you provide us with relating to promotions and will be processed based on your consent (indicative: preferences, age, etc.).

The above information is collected directly from you and not from third parties. The Company is not responsible for the collection of your personal data by employees (e.g., shops, restaurants), in the context of the services you request from third parties (e.g., transactions, reservations).

The processing of your personal data is undertaken for the following reasons:

- For your entry to the Beach and the use of the services you have requested, either in the context of online booking through the website [www.astir.gr](http://www.astir.gr) or purchasing an entrance ticket from the ticket office of the Beach, or in the context of your participation in a privilege program (Platinum Card, Black Card). The legal basis of the processing is the provision of the requested service (contract execution)
- For the safety of the Beach facilities, employees, and visitors. The processing is based on the legal interest of the Company to safeguard the security of its facilities and the people who use or work in them.
- To provide you with first aid, if needed. Treatment is necessary for the purposes of professional medicine, medical diagnosis and first aid.
- For the management of requests and complaints that you submit to the Company. The processing is based on the legal interest of the Company to monitor and improve the quality of its services.
- To serve the legal interests of the Company or a third party and to the extent that your fundamental rights or freedoms do not prevail.
- For promotions or other actions if you have given us your consent to this.

Your data can only be accessed by our duly authorized employees and trusted associates, such as (a) security companies and (b) advertising companies. The employees of the Company are committed under special procedures to observe the security of your data and have been appropriately trained for this purpose. The third-party cooperating companies have signed the necessary contracts that safeguard the legal and secure processing of your data.

The retention period of your personal data varies according to the data category and the processing purposes. The maximum retention period of the data is ten (10) years from the year in which they were collected. The data collected during the closed-circuit operation of the television are kept for a maximum duration of fifteen (15) days. Especially for service of newsletters and other updates, you can unsubscribe at any time by following the relevant link in the newsletters or SMS you receive. After the expiry period of retention, your data is safely destroyed.

Your personal data are not transmitted outside the EU / EEA.

You have the right to:

- information and access to your personal data
  - correction of your personal data if they are inaccurate or incomplete
  - deletion of your personal data, to the extent permitted by Law
  - request the restriction of the processing of your personal data, to the extent permitted by Law
  - request the portability of your personal data
  - oppose the processing, which may take the form of withdrawing your consent. The processing of the data occurring prior to the revocation of your consent is not affected.

- If you have any request or query relating to the processing of your personal data by the Company, you can send this in writing to the above contact details and to the attention of the Data Protection Officer.
- If you believe that your data protection rights have been violated, you can appeal to the Personal Data Protection Authority ([www.dpa.gr](http://www.dpa.gr)).

This Regulation has been drafted by the Company, which reserves the right to amend it in the future.

The terms of entry, opening hours, and use of the Beach facilities are defined by the Company, which reserves the right to modify them according to the season.

The Beach Management has the right to deny entry to guests who have a history of violent behaviour or have initiated violent incidents in the past on the Beach.

The Beach Management has the right to remove people from the Beach who are intoxicated, under the influence of drugs or behave violently / inappropriately towards other visitors.

In case of any of the above incidents or in the event of another criminal offense being committed on behalf of a bather, the Company has the right to file a lawsuit.

For any complaints or suggestions for improvement, please use the Complaints / Suggestions Box located at the Beach entrance.

On purchasing an entrance ticket, all the above terms and regulations are automatically accepted by the visitor / customer.

The Operating Regulations have been posted at the main entrance of the Beach for public information and are distributed free of charge upon request.
